Metals Australia Limited (Company) is pleased to advise that the Company has issued the following securities today:

 40,000,000 Ordinary Fully Paid Shares to the vendors of Payne Gully Gold Pty Ltd (PGG), being part consideration to acquire 80% of PGG, with 84,000,000 Ordinary Fully Paid Shares and a cash payment of \$300,000 to the PGG vendors remaining subject to shareholder approval as detailed in the ASX announcement dated 16 June 2022.

The Shares are part of a class of securities quoted on the Australian Securities Exchange Limited (ASX).
